FINANCIAL REQUIREMENTS

To qualify, applicants must demonstrate sufficient passive income from outside Greece.

Minimum Monthly Income Required:

- **€3,500** for the main applicant
- **+20% (€700)** for a spouse
- **+15% (€525)** for each dependent child

Applicants must also secure long-term accommodation in Greece (rental or owned) and hold private health insurance covering medical expenses and repatriation.

REQUIRED DOCUMENTS

- Valid passport (minimum 6 months validity)
- Proof of employment or business activity outside Greece
- Bank statements or payslips proving income for the past 3 months
- Rental agreement or property ownership in Greece
- Private health insurance for all applicants
- Clean criminal record certificate
- Civil status documents for dependants

All non-Greek documents must be officially translated and legalised.

ESTIMATED COSTS

- **Government Visa Fee:** €75 per applicant
- **Residence Permit Fee:** €150 per applicant (if applying for renewal)
- **Health Insurance:** €300 – €1,000 per person annually
- **Document Translation & Legalisation:** €300 – €500
- **Legal Assistance Fees:** €5,000 – €12,000 (depending on family size and case complexity)
- **Accommodation Costs:** Rental prices start from €600 per month in major cities
